O.J. Miles made a motion to approve the minutes of the May meeting, seconded by Paul Merritt and unanimously approved by the board.

Dennis Simpson welcomed the newest board member, Dick Owens.

The Treasurer report was given by Paul Merritt. Merritt stated he and the Finance Committee with Kevin Meacham had put together the final budgets to be presented to the courts. Final expenses for some courts are waiting on cost of lawn contractors' costs - Majorca 4, Lanza and Divino.

A motion was made to approve a 5th CD, \$250,000 with 5.3% return. Motion to approve by Jean Roberts; 2^{nd} Todd Woodward. It passed unanimously.

ARC - David Anderson reported the committee had approved 2 landscape requests. One request had been denied by the POA.

SC&C - Tom Dean was approved to be assistant court rep in Villa Allegra.

Gary Smith reported 2 units are in litigation and the THA has liens on both units.

Kevin Meacham, General Manager, submitted a progress report. See attached.

No decision on Work Meetings or Meeting dates.

State of Divino - still waiting on Statement of Understanding. There is no set budget due to not having numbers for lawn fees.

A discussion on the cost of voting by mail had risen due to today's postal rates. Dennis Simpson reported he had looked into a few companies that help organizations vote by e-mail. The companies have safe and secure ways to vote using e-mail. The cost for these services is much lower than using the US Postal Service.

Todd Woodward made a motion to amend THA bylaws to include email voting. Second, Jean Roberts. Passed unanimously. PLEASE NOTE....This motion was presented and passed in the April 21, 2023. The Minutes for the April meeting were approved in the May 19, 2023, meeting.

Paul Merritt and the Finance Committee have completed studies and have compiled new budgets for all courts, with exception of Divino. These new budgets were done because of the increase in all costs for maintaining courts due to today's economy.

Todd Woodward made a motion to accept proposed budgets. Jean Roberts 2nd and the board vote was unanimous to accept.

Dennis Simpson presented a presentation on new budgets using pie charts for each court. The charts broke down each court's budget and showed percentages of where monies are used. These charts will be used at the meetings with the individual courts to go over budgets.

- *Petition for leaf removal in unmaintained areas sent out for Cortez to vote
- *Live traps set to catch and relocate raccoons
